


**ORDINANCE NO. 01-2013**

**AN ORDINANCE ESTABLISHING THE APPROPRIATIONS FOR THE CHAPLAIN FUND, MONTHLY  
DIVERSION FEES FUND, AND LAW ENFORCEMENT – COUNTY COURT FUND**

Be it ordained by the Town of Plainfield, Indiana: That for the expenses of the Chaplain Fund, Monthly Diversion Fees Fund, and Law Enforcement – County Court Fund for the year ending December 31, 2013, the sums of money shown on the Budget Form 1's as made a part of the budget report and submitted herewith are hereby appropriated and ordered set apart out of the funds herein named and for the purposes herein specified, subject to the laws governing the same. Such sums herein appropriated shall be held to include all expenditures authorized to be made during the year, unless otherwise expressly stipulated and provided for by law.




