NOW, THEREFORE, be it ordained by the Town Council of the Town of Plainfield, Indiana in accordance with I.C. §36-1-10.5-5 as follows:



2. The Town Council, as purchasing agent, hereby appoints Mark Keutzer and Gary Raasch to appraise the described parcels to determine the fair market value.


