FILING READINESS DETERMINATION (FRd): Applicant files digital copies of plans at least one (1) week prior to the FRd (Filing Readiness Determination) meeting at TAC through iWorQ. *This is an internal review.* Staff provides a general technical review to catch as many potential issues as possible.

REVIEW AND REVISIONS: Staff, the Design Review Committee, and the Technical Advisory Committee review and provide comments to the applicant.

PLAN RESUBMITTAL AND LEGAL NOTICE DEADLINE: The Staff provides the legal notice to the applicant for mailing. Staff will have the notice published in the paper of record and will be reimbursed by the applicant. The applicant will do a resubmittal of plans for the Plan Commission.

STAFF DETERMINATION AND REPORTS: Staff will review the resubmitted plans and determine whether the submitted plans are sufficient for submittal to the Plan Commission. *Any plans or revised plans submitted after the Plan Resubmittal date may result in the project being continued to a later public hearing.*
