RESOLUTION SETTING DATE FOR PUBLIC HEARING  
REGARDING ANNEXATION OF CERTAIN PROPERTY TO THE TOWN  
(Williamson North Farm/Rock Creek; Northwest & Northeast Corners of  
East 750 South & South 975 East)

WHEREAS, a Petition For Voluntary Annexation Into The Town of Plainfield, Indiana (the "Petition") was filed with the Town Council of the Town of Plainfield, Indiana (the "Town Council" and "Town," respectively) on August 14, 2020;

WHEREAS, the Petition requests that the Town annex certain contiguous property and is signed by all landowners residing within the territory proposed to be annexed which territory depicted in the territory map attached hereto as Exhibit A and is described in the legal description attached hereto as Exhibit B; and

WHEREAS, the Town desires to set a date for a public hearing on the proposed annexation (the "Public Hearing"), in accordance with the provisions of Indiana Code Sections 36-4-3 et. seq., at which the Town Council will receive and hear comments, remonstrance, and objections from interested persons concerning the proposed annexation.

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE TOWN COUNCIL, THAT:

1. The Town Council shall hold the Public Hearing on October 12, 2020 at 7:00 p.m. (Local Time) at the Plainfield Town Hall, located at 206 W. Main Street, Plainfield, Indiana 46168.
2. Notice of the Public Hearing shall be published in the *Indianapolis Star* no later than September 22, 2020.

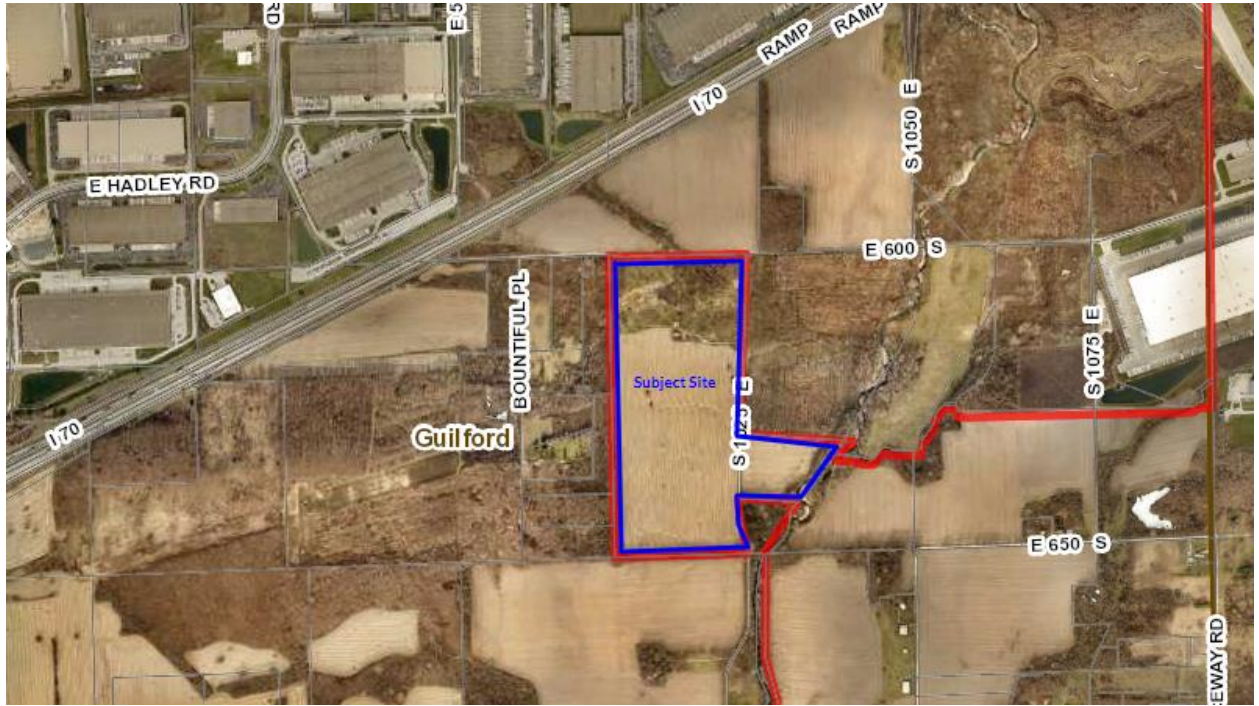

THENCE SOUTH 84 DEGREES 53 MINUTES 33 SECONDS EAST 990.91 FEET (PREVIOUS DEED 14 CHAINS 27 LINKS) TO THE CENTER OF THE EAST FORK OF WHITE LICK CREEK; THENCE FOLLOWING SAID CREEK SOUTH 47 DEGREES 49 MINUTES 59 SECONDS WEST 562.08 FEET; THENCE FOLLOWING SAID CREEK, SOUTH 10 DEGREES 24 MINUTES 43 SECONDS WEST 192.14 FEET; THENCE NORTH 84 DEGREES 55 MINUTES 11 SECONDS WEST 579.65 FEET TO THE CENTER OF COUNTY ROAD 1025 EAST; THENCE SOUTH 02 DEGREES 29 MINUTES 31 SECONDS EAST, 132.78 FEET; THENCE SOUTH 09 DEGREES 53 MINUTES 42 SECONDS EAST, 346.79 FEET TO THE SOUTH LINE OF SAID QUARTER SECTION; THENCE SOUTH 89 DEGREES 42 MINUTES 18 SECONDS WEST ALONG SAID SOUTH LINE 1185.62 (PREVIOUS DEED 18.13 CHAINS) TO THE SOUTHWEST CORNER OF SAID QUARTER SECTION; THENCE NORTH 01 DEGREES 25 MINUTES 50 SECONDS EAST 2662.07 FEET (PREVIOUS DEED 40 CHAINS 26 LINKS) TO THE POINT OF BEGINNING.
