

**PLAINFIELD TOWN COUNCIL
ORDINANCE NUMBER 25-2020**

**An Ordinance Establishing A Three-Way Stop at the
Intersection of Terry Drive and Springcrest Street**

WHEREAS, the Town of Plainfield, Indiana (“Town”) has adopted the Plainfield Town Code (“Town Code”); and

WHEREAS, the Town Code includes rules and regulations regarding stop intersections in the Town; and

WHEREAS, the Town Council has determined that it is in the best interest of the Town to amend certain provisions of the Town Code relating to a stop intersection at Terry Drive and Springcrest Street.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF PLAINFIELD, INDIANA AS FOLLOWS:

Chapter 75: Traffic Schedules, Schedule III. Stop Intersections of The Plainfield Town Code is hereby amended by adding the following Division (P);

- (P) Three-way stop at the intersection of Terry Drive and Springcrest Street:
- (1) The intersection of Terry Drive and Springcrest Street, in the corporate limits of the Town, is established as an intersection to be controlled with a three-way stop.
 - (2) The intersection of Terry Drive and Springcrest Street shall be converted from an existing intersection with a single stop sign for a private drive to a three-way intersection. The existing stop sign at the drive from 1350 Terry Drive shall continue to be the responsibility of the property owner to maintain and keep visible as an effective traffic control device. Stop signs and stop bars shall be installed on both Terry Drive and Springcrest Street.
 - (3) Traffic control and appropriate traffic signs creating a three-way stop at the intersection of Terry Drive and Springcrest Street as described herein is authorized.

THIS ORDINANCE shall be in full force and effect from and after its passage, adoption and any publication required by law.

SAID ORDINANCE IS HEREBY PASSED AND ADOPTED this 26th day of October, 2020.
