**A RESOLUTION OF THE PLAINFIELD TOWN COUNCIL
TO EXECUTE A MEMBERSHIP AGREEMENT IN THE
INDIANA PUBLIC EMPLOYER'S PLAN, INC.**

WHEREAS, pursuant to IC 36-1-7 and IC 23-17-1, the Town of Plainfield, desires to combine with other governmental entities of the State of Indiana in a group self-funded program to be known as the "Indiana Public Employers' Plan, Inc.", an Indiana not-for-profit corporation, (hereinafter referred to as "IPEP" or the "Plan") for the purpose of paying and administrating their respective obligations to their employees and dependents under the Indiana Workers' Compensation Act (IC 22-3-2 through IC 22-3-7), the Indiana Employers' Liability Act (IC 22-3-9), hereinafter referred to as the "Acts", and;

WHEREAS, as the governing body of the aforesaid governmental entity of the State of Indiana, as defined by IC 34-6-2-49, (formerly 34-4-16.5-2(c), we desire to give and grant authority to the below-named person to execute for and on behalf of this body a Membership Agreement with the Plan and to provide and execute such other documents as are necessary to affect membership in and the purposes of the Plan.

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Plainfield, Indiana as follows:

1. Robin G. Brandgard, Town Council President is hereby authorized to execute for and on behalf of this body a Membership Agreement in the Indiana Public Employers' Plan, Inc., ("Plan") and provide and execute such other documents as may be necessary to affect membership in and the purposes of the Plan.

2. The fiscal officer of Town of Plainfield, is hereby authorized to pay or cause to be paid any and all amounts required of the Plan in order to affect membership in and the purposes of the Plan, subject to the prior appropriation of such amounts by the body.


ROSTERED VOLUNTEER ADDENDUM

This Addendum is made by and between the Indiana Public Employers' Plan, Inc. (Plan) and Town of Plainfield (Member), for the purposes of amending the Membership Agreement, dated February 8th, 2021, for the following purpose:

- a. The Member elects to bring its rostered volunteers under the medical provisions of the Workers' Compensation Act pursuant to the authority contained in Public Law 51-1993 (IC 22-3-2-2.1).
- b. Rostered Volunteer, for purposes of this coverage agreement, is defined as any non-payroll individual, identified to the Plan, performing any assigned duty on behalf of the Member, whether or not the individual receives expense reimbursement or other benefit from the Member.
- c. Occurrence, for purposes of this addendum, is defined as any accident involving one or more Rostered Volunteers while performing assigned volunteer duties, resulting in bodily injury to one or more Rostered Volunteers arising out, and in the course of, said duties.
- d. Attached to this Addendum is a listing (Form RV-1) of the Rostered Volunteers who Member intends to cover under this election. The completed Form RV-1 must be submitted to the Plan for coverage to be in force in advance of any Occurrence involving a Rostered Volunteer.
- e. Member agrees to pay any additional contribution to the Plan necessitated by the coverage of Rostered Volunteers.
- f. Member agrees to maintain a current roster of all volunteers to which this election applies and to submit an amended Form RV-1 to the Plan whenever volunteers are added.
- g. Member agrees that coverage provided under this addendum is limited to excess expenses after all other applicable insurance has paid submitted claims.
- h. Member agrees that the maximum amount payable under this addendum for any one occurrence, whether individual or aggregate loss, is \$25,000. This maximum does not apply to volunteers who are injured while engaged in assigned public safety duties.
- i. Member acknowledges that this Addendum affects the Member Agreement described above only to the extent provided herein.
