**A RESOLUTION ADOPTING THE HENDRICKS COUNTY
MULTI-HAZARD MITIGATION PLAN (MHMP)**

WHEREAS, the Multi-Hazard Mitigation Planning Committee prepared the Hendricks County Multi-Hazard Mitigation Plan (MHMP), a copy of which is incorporated herein by reference. The Committee included representatives from Hendricks County Commissioners, Hendricks County Departments, the Town of Amo, the Town of Avon, the Town of Brownsburg, the Town of Clayton, the Town of Coatsville, the Town of Danville, the Town of Jamestown, the Town of Lizton, the Town of North Salem, the Town of Pittsboro, the Town of Plainfield, the Town of Stilesville, the Town of Danville Fire Department, and various agencies. The Committee was assisted by Christopher B. Burke Engineering Ltd; and

WHEREAS, the Multi-Hazard Mitigation Plan (MHMP) recommends many activities which will protect the people and property of the Town of Plainfield, which are affected by natural hazards, and

WHEREAS, the Town of Plainfield is a voluntary participant in the National Flood Insurance Program.

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Plainfield, Indiana, as follows:

1. The adoption of the Multi-Hazard Mitigation Plan (MHMP) does not obligate or mandate Hendricks County to use local tax money for projects identified in any Multi-Hazard Mitigation Plan (MHMP).
2. The Multi-Hazard Mitigation Plan (MHMP) for Hendricks County, Indiana is hereby adopted as an official plan of Hendricks County.
3. This Resolution shall be in full force and effect from and after its adoption by this board and shall repeal and replace all previous MHMP plans.
