RESOLUTION NO. 2022-25

**RESOLUTION TO ALLOW FOR A REIMBURSEMENT FROM THE FIRE
TERRITORY EQUIPMENT REPLACEMENT FUND TO THE CUMULATIVE
CAPITAL IMPROVEMENT FUND FOR THE PREPAYMENT OF CERTAIN FIRE
EQUIPMENT**

WHEREAS, the Town Council of the Town of Plainfield, Indiana finds that the Fire Territory Equipment Replacement fund (103) (“TER 103 fund”) does not have sufficient cash and appropriations available for the prepayment of certain fire equipment (ladder truck) for the Plainfield Fire Territory; and

WHEREAS, there is remaining in the Cumulative Capital Improvement fund (407) (“CCI 407 fund”) an unused and unencumbered balance; and

WHEREAS, the fire equipment purchase is an eligible expense of both the TER 103 fund and the CCI 407 fund; and

WHEREAS, the Town of Plainfield can benefit from significant savings by prepaying for the equipment purchase from the CCI 407 fund; and

WHEREAS, reimbursements from the TER 103 fund shall be made in the amounts and at the times approved by the Plainfield Town Council commencing with the year 2023 thru 2027; and

WHEREAS, the total amount of these transfers shall not exceed the original prepayment amount.

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE TOWN COUNCIL, that the Town Council of the Town of Plainfield does hereby approve the use of funds held in the CCI 407 fund for the prepayment of the purchase of a ladder truck for the Plainfield Fire Territory and, further, approves the reimbursement of the prepayment from the TER 103 fund to the CCI 407 fund in amounts owed and at the times approved by the Plainfield Town Council.
