RESOLUTION SETTING DATE FOR PUBLIC HEARING  
REGARDING ANNEXATION OF CERTAIN PROPERTY TO THE TOWN  
- West half of 6487 S CR 600 E -

WHEREAS, a Petition For Annexation Into the Town of Plainfield, Indiana (the “Petition”) was voluntarily filed with the Town Council of the Town of Plainfield, Indiana (the “Town Council” and the “Town,” respectively) on Nov 30, 2022;

WHEREAS, the Petition requests that the Town annex certain contiguous property described therein and is signed by all owners of land within the territory proposed to be annexed, which territory depicted in the territory map attached hereto as Exhibit A and is described in the legal description attached hereto as Exhibit B; and

WHEREAS, the Town desires to set a date for a public hearing on the proposed annexation (the “Public Hearing”), in accordance with the provisions of Indiana Code Sections 36-4-3, *et seq.*, at which the Town Council will receive and hear comments, remonstrance, and objection from interested persons concerning the proposed annexation.

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE TOWN COUNCIL, THAT:

1. The Town Council shall hold the Public Hearing on June 26, 2023, at 7:00 p.m. (local time) at the Plainfield Fire Territory Headquarters, 591 Moon Road, Plainfield, IN 46168.
2. Notice of the Public Hearing shall be published in the *Indianapolis Star* on or before June 4, 2023.

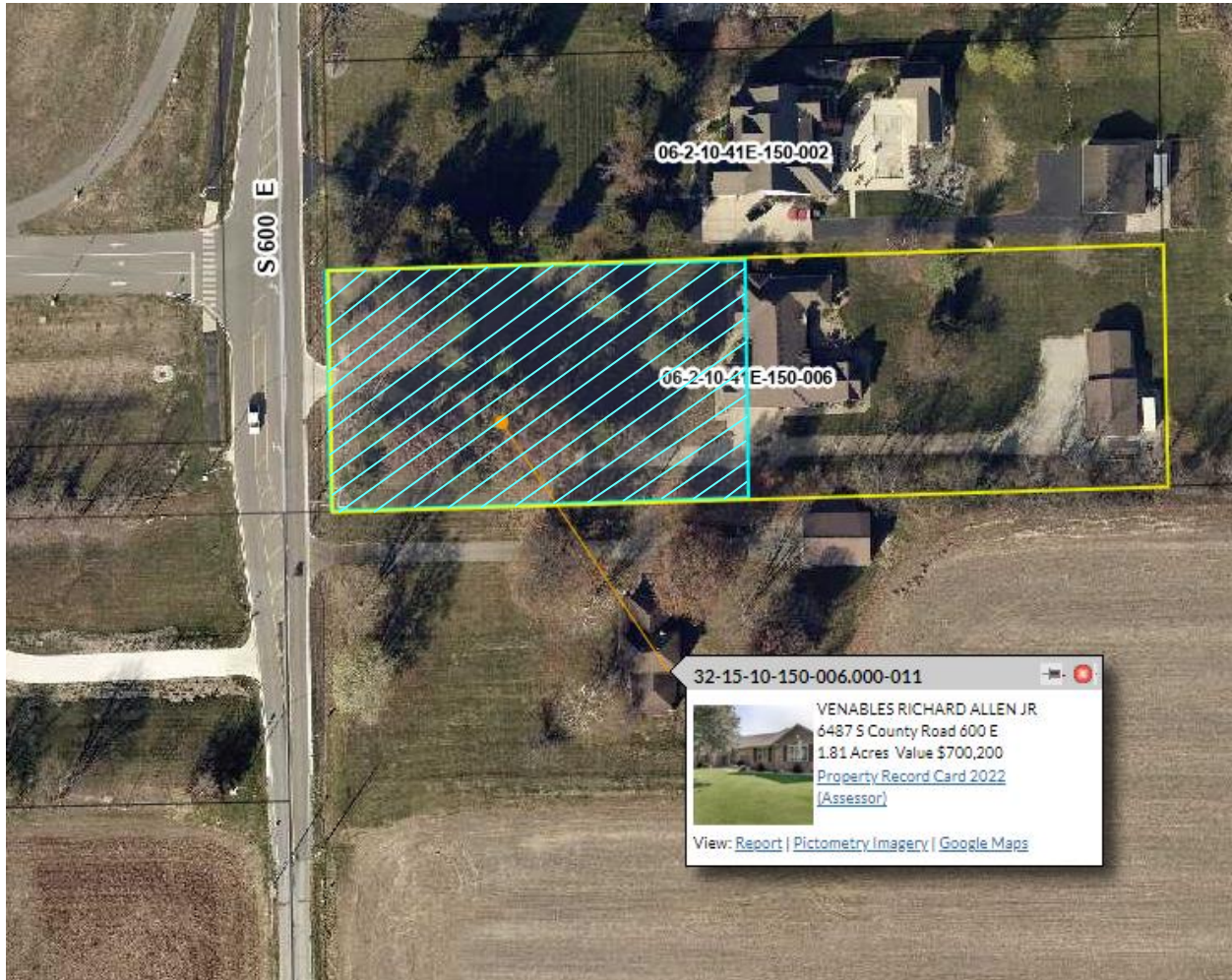

**LAND DESCRIPTION WEST HALF**

The **west** half of Lot 1 in the Replat of Lot #1 in Minor Plat 459 recorded as Instrument Number 199626377, in Plat Cabinet 4, Slide 46, Page 1 in the Office of the Recorder in Hendricks County, Indiana, being more particular described as follows:

BEGINNING at the northwest corner of said Lot; thence North 89 degrees 35 minutes 31 seconds East along the north line of said lot 260.90 feet; thence South 00 degrees 00 minutes 00 seconds East 151.04 feet to the south line of said lot; thence South 89 degrees 43 minutes 29 seconds West along the south line of said lot 260.90 feet to the southwest corner thereof; thence North 00 degrees 00 minutes 00 seconds West along the west line of said lot 150.44 feet to the POINT OF BEGINNING, containing, 0.903 acres, more or less.
